Description: REASON FOR EXTENSION REQUEST

THE COMMISSION HAS PREVIOUSLY BEEN ADVISED THAT THE LICENSEE LOST ITS LEASE FOR STATION WGIV(AM)'S LICENSED SITE AND HAS BEEN OPERATING FROM AN STA SITE (ASR 1226644)(COORDINATES: NORTH LATITUDE 35-11-56 AND WEST LONGITUDE 80-52-36) USING A 110-FOOT VERTICAL LONG WIRE WITH A POWER OF 25 WATTS OPERATING A LPB RC-25B TRANSMITTER. THE COMMISSION HAS ALSO PREVIOUSLY BEEN ADVISED THAT THE LICENSEE HAS OBTAINED FCC APPROVAL IN FILE NUMBER BP-20190906AAU TO CONSTRUCT AND OPERATE THE STATION AT A NEW TRANSMITTER LOCATION (THE "CP SITE"). THE LICENSEE HAS SUBSTANTIALLY COMPLETED CONSTRUCTION AT THE CP SITE. THE LICENSEE IS NOW WAITING ON THE LOCAL POWER COMPANY TO FINISH INSTALLATION OF ELECTRIC SERVICE TO THE CP SITE AND APPROVAL BY THE POWER COMPANY TO ENERGIZE THE STATION'S TRANSMITTER AND OTHER EQUIPMENT AT THAT LOCATION. PENDING COMPLETION OF THESE FINAL STEPS OF ELECTRIC POWER PROCUREMENT FOR THE CP SITE, THE LICENSEE RESPECTFULLY REQUESTS ANOTHER EXTENSION OF THE COMMISSION'S SPECIAL AUTHORITY FOR OPERATION OF THE STATION WITH THE ABOVE-SPECIFIED TEMPORARY FACILITIES AT THE CURRENT STA SITE.
