Lancaster Educational Broadcast Service
Request of Temporary Operations
Engineering Special Temporary Authority
KLQS-LP, Agua Dulce, CA Facility ID No. 195731

Lancaster Educational Broadcast Service ("LEBS") is filing this request for Engineering STA due to technical and economic problems regarding its current broadcast site for KLQS-LP. Since the station was licensed, it has been attempting to find a broadcast site that will work to cover its immediate community with a viable signal. The station is located in a canyonous area east of Santa Clarita (hence the adjacent community is named "Canyon Country"), there are few sites that work for coverage and meet the terms of second-adjacent channel interference protection. Last year LEBS trialed two sites for better coverage which did not work out as planned. It did, however, find a site of vastly superior coverage that met the needs of the station, but the relocation site was greater than 5.6 km away -- the maximum distance a LPFM can move. It instead requested a waiver from the FCC to move greater than 5.6 km, citing that its situation was much more compelling and in the public interest compared to several waivers of the rule the FCC had previously granted. The FCC denied that request, because it has, without reason, stopped granting these waivers. That application was asked to be reconsidered just short of a year ago. However, since then, a FCC rulemaking to change the minor change in distance relocation was recently enacted via a recent Report and Order.¹ Under this new rule, KLQS-LP's pending application could be granted. Although the Order has been put into effect, a couple rule changes from the Order are held up for review by OMB, which is soon to be reviewed.² KLQS-LP currently is on Silent STA and needs to return

to the airwaves by August 13, 2020. LEBS asked the FCC if it would approve its pending request for construction permit to move prior to this date with a waiver while the new rule is still pending. The reason is that it would be extreme hardship to sign a lease for the current licensed spot for another year, which has non-usable coverage, to simply wait for the new rules to come into effect to have the new CP approved and move. The Audio Division suggested utilizing an Engineering STA to temporarily broadcast at a suitable location until the rule can be changed and the new CP site can be approved. Hence, an Engineering STA is now being applied for.

It is in the public interest to maintain independent, local community radio programming retained for the Agua Dulce area. LEBS is a non-profit licensee and operates KLQS-LP on a noncommercial educational basis. The organization would like to retain the station license for local independent "community radio" broadcasting. LEBS is respectfully requesting express consideration and processing to move to temporary location to continue broadcast.

The duration of this broadcast would be for the time it take OMB to change rulemaking, and have the FCC approve pending construction permit application plus two weeks to place that facility on the air.
