

Correction to Request for Change of Parent Station

Dear Ms. Dortch:

Family Stations, Inc. ("Family"), licensee of KHFR(FM), Santa Maria, California, requested a waiver of the Commission's main studio requirement, 47 C.F.R. Section 73.1125, in order to operate KHFR(FM) as a satellite of its commonly owned noncommercial educational station, KEAR-FM (formerly KEDR(FM)), Sacramento, California. On December 3, 2003, the Commission granted the request. The Commission determined that it was in the public interest and so authorized KEAR-FM, (formerly KEDR(FM)), Sacramento, California to operate as the parent station to KHFR(FM). On November 9, 2005, Family filed a Notification of Change of Parent Station requesting that KECR(FM), El Cajon, California, be allowed to operate as the parent station to KHFR(FM).

Family hereby notifies the Commission that there has been no change to the operation of KHFR(FM) and that KEAR-FM (formerly KEDR(FM)) is still operating as the parent station of KHFR(FM) until such time as the Commission grants authority to operate KECR(FM) as the parent station of KHFR(FM).
