This report has been prepared on behalf of Hometown Broadcasting of Portsmouth 2 (HBP2) in support of its application to acquire, through the filing of FCC Form 314, the construction permit, BPH-19970911MY, for a new commercial broadcast station WNPM-FM at Portsmouth, Ohio. A principal of HBP2 holds attributable interests in the licensees of WNXT(AM) and WNXT-FM Portsmouth, Ohio and WLGC(AM) and WLGC-FM of Greenup, Kentucky. Therefore, in response to the requirements of Section 73.3555(a)(1) of the FCC Rules HBP2 is obligated to present a study of the radio market concerning the authorized facilities of WNPM and the holdings of attributable interests of the licensees of HBP2 as well as a study of the proposed facilities of WNPM and of HBP2.

The radio market between the WNPM-CP and the attributable interests of HBP2 consists of the overlapping contours of WNPM-CP, WNXT-FM and WNXT(AM) of Portsmouth, Ohio and WLGC-FM and WLGC(AM) of Greenup, Kentucky. The radio market between Proposed WNPM and the attributable interests of HBP2 includes Proposed WNPM, WNXT-FM and WNXT(AM), of Portsmouth, Ohio and WLGC-FM and WLGC(AM) of Greenup, Kentucky. These radio market areas are included herein on the attached map titled "Hometown Broadcasting of Portsmouth 2 LMA/Duopoly Map". The details of the study concerning the WNPM authorized facilities (WNPM CP) are included in the tabulation entitled "Hometown Broadcasting of Portsmouth 2 and WNPM CP Duopoly Study". The details of the study concerning the proposed modification of WNPM facilities (Proposed WNPM) are included in the tabulation entitled "Hometown Broadcasting of Portsmouth 2 and Proposed WNPM Duopoly Study". It is concluded from the analysis of the Duopoly studies attached, that, there are a total of twenty-two (22) licensed commercial stations in the market area of which eight(8) stations have transmitters located within the radio market area and the other fifteen(15) stations city grade signals overlap some portion of the radio market area. This leads to the further conclusion that the proposed acquisition is in compliance with the FCC multiple ownership Rule.
