**MEDIA INTERESTS**

The assignor, Mega Communications of Silver Spring Licensee, L.L.C. (“Mega Licensee”), is a Delaware limited liability company. The sole member and owner of Mega Licensee is Mega Communications of Silver Spring, L.L.C. (“Mega Silver Spring”), another Delaware limited liability company. The sole member and owner of Mega Silver Spring is Mega Communications, L.L.C. (“Mega L.L.C.”), which is also a Delaware limited liability company. The sole member and owner of Mega L.L.C. is Mega Communications Holdings, L.L.C. (“Mega Holdings”), which is also a Delaware limited liability company. Mega Holdings is governed by a board of managers composed of Alfredo Alonso, George L. Lindemann and Adam M. Lindemann, who are also members of the company. In addition, Activated Communications Limited Partnership (“Activated”) holds 89 percent of the equity and 49 percent of the total membership votes in Mega Holdings.
