

## EXHIBIT 6

### Agreements to Transfer of Control

This application and associated concurrently filed applications seek the Commission's consent to the transfer of control of the following licensees and permittee and their associated radio broadcast authorizations from control by Dean Goodman as sole Manager of GoodRadio.TV, LLC to control by Verax Capital GP, LLC ("Verax"), which, upon consummation of the transfer pursuant to Commission consent, (i) will receive authority to appoint three of the five managers of a new Board of Managers that thereafter will control GoodRadio.TV, LLC and (ii) will convert the currently non-voting membership interests in GoodRadio.TV, LLC held by funds controlled by Verax to voting interests:
