Request that action on subject application be withheld for 180 days**

Dear Ms. Dortch:

I am writing to you on behalf of my client, Pentecostal Church of God ("PCG"). PCG is the proposed assignee of Station KRRF(AM), Murray, Utah (File No. BAL-20170119ABG, granted Mar. 3, 2017). On February 17, 2017, PCG filed the above-referenced Form 301 minor change application with the permission of the licensee, Radio License Holding CBC, LLC ("Cumulus"). On May 11, 2017, PCG's counsel was informally advised by Cumulus that PCG should file a letter asking the Commission's Audio Division to withhold further action on the subject modification application for the next 180 days to allow time for PCG to file a curative amendment containing a tower registration number along with an acceptable environmental showing. This is that letter, and an original and two (2) copies are being hand-delivered to the Commission today for filing.

Since the beginning of 2017, PCG has been diligently proceeding to make grant of the referenced modification application possible. The application was necessitated by the fact that the sale of Station KRRF to PCG did not include a transmitter site. PCG proposes to erect its transmitter tower on or adjacent to its church building, and it has filed for an FAA no-hazard determination and has been working with local zoning authorities and engineering consultants, including Mr. Garth M. Woolsey of Woolsey Design, LLC and Mr. Clarence M. Beverage of Communications Technologies, Inc., for approvals. Although PCG has been informally advised by the FAA and zoning authorities that approvals are forthcoming, the process has taken much more time than expected. PCG apologizes for these delays, but they are beyond its control.


Therefore, PCG respectfully requests that further action on its modification application be withheld
