This is in reference to the request filed on May 30, 2017. KBL requests an extension of the STA granted on January 30, 2017, to continue operating with reduced daytime power due to severe interference to nearby station KSCR(AM), ID#30649, causing it's transmitter to shut down.¹ In support of the request, KBL states that it must continue STA operation pending installation of all required equipment at the KCSR's transmitter site (located 0.6 miles away) to eliminate the interference.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem


Accordingly, the request for extension of STA IS HEREBY GRANTED, and KBL may continue to operate during daytime hours with reduced power of 1.5 kilowatts in order to prevent interference to KSCR(AM), with no change to the licensed 0.105 kW nighttime operation. KBL must use whatever means are necessary to protect workers and the public from exposure to radio

frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310. KBL must submit an e-mail to certify the date the station resumed licensed operations per BL-20161117ACA with negligible changes to all operating parameters after all repairs at the KSCR(AM) transmitter site have been completed.

This authority expires on **December 29, 2017**.
