Dear Licensee:

This is in reference to the request filed May 22, 2015 on behalf of Montecito FM, Inc. ("MFI"). MFI requests a seventh extension of the special temporary authority ("STA") granted on December 5, 2011, to operate Station KJEE with temporary facilities.<sup>1</sup> In support of the extension request, MFI re-states that the licensed site was heavily damaged by wildfire and that MFI was required to reduce power for the protection of workers during the reconstruction efforts. MFI had filed construction permit application (file no. BPH-20131120ADR) to relocate the station and upgrade to Class B1, but that application was dismissed March 31, 2015 and the station's license modified to operate on Channel 225A. MFI is currently reviewing the implications of that action.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

<sup>1</sup> KJEE is licensed for operation on Channel 225A (92.9 MHz) with effective radiated power of 0.82 kilowatt (H&V) and antenna height above average terrain of 270 meters.

We find that an extension of the STA is warranted, and the request for extension of STA IS HEREBY GRANTED. Station KJEE may continue to operate with the following facilities:

Geographic coordinates:	34° 27' 57" N, 119° 40' 37" W (NAD 1927)
Channel	225A (92.9 MHz)
Effective radiated power:	0.2 kilowatt (H&V)
Antenna height:	
above ground:	5 meters
above mean sea level:	664 meters
above average terrain:	270 meters

MFI must notify the Commission when permanent operations commence. MFI must use whatever means are necessary to protect workers and the public from radiofrequency exposure in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

**This authority expires on December 1, 2015.**
