

**SECOND AMENDMENT TO LIMITED PARTNERSHIP
AGREEMENT OF
AMERICOM LAS VEGAS LIMITED PARTNERSHIP,
a Nevada Limited Partnership**

This Second Amendment to Limited Partnership Agreement of Limited Partnership of Americom Las Vegas Limited Partnership, a Nevada Limited Partnership (the "Partnership"), dated as of November __, 2003 is made by and among the parties set forth below. The parties set forth below constitute the present general partners and a majority in interest of both the present limited partners and all persons who were limited partners at the time of the First Amendment of said Partnership.

Subject to any required approvals of the Federal Communications Commission ("FCC"), the Limited Partnership Interest of City News Service of Los Angeles, Inc. is transferred to Radio Partners and Radio Partners is admitted as a Limited Partner, a portion of the Limited Partnership Interest of A. Thomas Quinn is transferred to Amy Quinn pursuant to the dissolution of their marriage, and one-half of the Limited Partnership Interest of Richard A. Nagler is transferred to Judy Nagler pursuant to the dissolution of their marriage.

The undersigned hereby agree, ratify and confirm that, subject to FCC approval, the general and limited partners of the Partnership, as well as their percentage allocations, are as set forth on Exhibit A attached hereto and incorporated herein by reference.

Each of the undersigned consent to any and all transfers, waive any restrictions contained in the Partnership Agreement in connection with any transfers resulting in the foregoing Partnership Interests and amend the Partnership Agreement solely to the extent necessary to reflect ownership of all of the Partnership Interests as set forth in Exhibit A.
