Bay 2 - 206.5 degrees True North

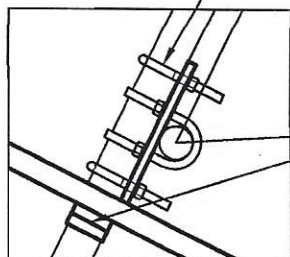
