Request for Waiver of Section 73.865 of the FCC Rules

Assignor hereby requests a wavier of Section 73.865 of the Commission's Rules based on the following criteria:

1) **Assignor will not make a profit from the sale of the LPFM station.**

The assignment will be effectuate by a Deed of Gift, in which Northcentral Technical College receives no consideration and will only be reimbursed for the transaction's legal fees. The Deed of Gift is an attachment to this application. No other remuneration for this transfer is contemplated.

2) **Assignee certifies that it is a "local" entity.**

The attached Declaration of Peter Yang, Executive Director of assignee Wausau Area Hmong Mutual Association ("WAHMA"), certifies that WAHMA's headquarters is physically located within Wausau, Wisconsin, and that 100% of WAHMA's board members reside within ten miles of the transmitter site of WNRB-LP.

3) **The assignee has no other broadcast interests.**

The attached Declaration of Peter Yang certifies that WAHMA has no other broadcast interests, and that none of WAHMA's board members has any attributable interest in any broadcast station.

4) **Detailed Educational Purpose.**

As set forth in the declaration of Peter Yang, and the attached portion of FCC Form 318, WAHMA is a nonprofit corporation formed for the advancement of an educational purpose. WAHMA will broadcast a program service of value to Wausau. That service will consist of programming dedicated to assisting community integration and economic and social advancement of Southeastern Asian refugees in Marathon County, featuring local, state, national and international news, community announcements, community education, music and song dedications. FURTHER DECLARATION OF PETER YANG

I, Peter Yang, under penalty of perjury, hereby declare as follows:

1. I am Executive Director of the Wausau Area Hmong Mutual Association ("WAHMA").
2. WAHMA is a nonprofit corporation organized under the laws of Wisconsin, and is recognized as a tax-exempt organization under Section 501(c)(3) of the Internal Revenue Code.
3. As indicated in the attached legal portion of FCC Form 318, WAHMA satisfies FCC requirements for becoming an LPFM licensee.
4. WAHMA will receive WNRB-LP via a Deed of Gift, by which it will not be paying Northcentral Technical College any consideration for the station, other than the reimbursement of their legal fees in preparing the agreements and filing the necessary FCC application.
5. Neither WAHMA, nor any member of the Board of Directors has any attributable interest in any medium of mass communications other than what they will acquire in WNRB-LP.
6. WAHMA's headquarters is physically located within Wausau, Wisconsin, and 100% of its board members reside within ten miles of the transmitter site of WNRB-LP.
7. WAHMA will broadcast a noncommercial program service dedicated to assisting community integration and economic and social advancement of Southeastern Asian refugees in Marathon County, featuring local, state, national and international news, community announcements, community education, music and song dedications.
