Dear Mr. Profitt:

This is in reference to the request filed on August 19, 2019. AML requests a second extension of the STA granted on August 15, 2018, to continue operating with reduced power until able to restore licensed operations.<sup>1</sup> In support of the request, AML states that additional time will be needed to complete repairs.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of the STA IS HEREBY GRANTED, and AML may continue to operate with reduced power. AML must use whatever means are necessary to



protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR §1.1310. AML must submit an e-mail to my attention to certify the date the station resumed licensed operations with negligible changes by installing a new 1 kW transmitter (if unable to repair the old one).

This authority expires on **March 10, 2020**.
