Dear Ms. Kreisman:

Pursuant to Sections 74.102 and 74.131 of the Commission's rules, 47 C.F.R. §§ 74.102, 74.131, on behalf of Citadel Communications Company, Ltd. (the "Company"), licensee of KCAU-TV, Sioux City, Iowa (the "Station"), we hereby request an experimental broadcast station authorization, to the extent necessary, for the Station to operate at 43.9 kW effective radiated power. As described in greater detail in the application for Special Temporary Authorization filed herewith (amending and superseding the STA request filed with the Commission on August 13, 2009, FCC File No. BDSTA-20090813ABN), the Station believes that the 43.9 kW operations would enable the Station to better serve the many viewers who are unable to receive the Station's digital signal on VHF channel 9.

An experimental authorization would enable the Station to test this hypothesis through a program that indicates a reasonable promise of substantial contribution to the development of broadcasting. Upon the authorization, the Station can and will proceed immediately with the program. The transmission of signals by radio is essential to the proposed program, which will be conducted by qualified personnel.

The undersigned is authorized to certify, and does hereby certify, on behalf of the Company, that neither the Company nor any party to the application is subject to a denial of Federal benefits pursuant to section 5301 of the Anti-Drug Abuse Act of 1988, 21 U.S.C. § 862.
