

The other entities and individuals that own BBGI voting stock are deemed non-attributable due to the Commission’s single majority shareholder rule. In addition, the former shareholders of Greater Media, Inc., which merged with BBGI in 2016, hold an attributable interest in BBGI based on their right to designate one director. Peter A. Bordes, Jr. currently serves as the designated director.

The equity not listed in the table above is either held as treasury stock or is owned by Beasley family members that are not BBGI officers or directors, estate planning trusts for the benefit of Beasley family members, members of the Bordes family or third parties. The only stock that could be owned by foreigners is the stock owned by the third parties. 4.4 % of the votes and 24.8% of the equity of BBGI is held by third parties. Beasley reviews the BBGI equity and voting stock holdings at least annually to determine compliance with the 25% foreign ownership limit. Beasley has confirmed that at least 20% of the BBGI equity owned by third parties is owned by US entities or individuals, and, therefore, no more than 19.8% (24.8 x .8) of the equity is owned by foreigners, and the company is in compliance with the FCC's foreign ownership restrictions.
