

**Comprehensive Exhibit; Description of the Transaction**

This application is one of two contemporaneously-filed applications filed on FCC Form 315 (collectively, “Applications”). One Application requests Commission consent to implement the restructuring of WPNT, Inc. (“WPNT”), and the other Application requests Commission consent to implement the restructuring of MGTF Radio Company, LLC (“MGTF”), in each case pursuant to the Joint Chapter 11 Plan of Reorganization of MGTF and WPNT, dated November 13, 2018 (as amended, modified and supplemented from time to time, the “Plan”). In accordance with the Plan, MGTF and WPNT will emerge from bankruptcy.

Consummation of the Plan will result in a substantial change of control of WPNT, but only the “pro forma” change of control of MGTF. However, for the purpose of administrative convenience, and in order to enable the ownership of a new entity to be “passed upon” by the Commission, two Applications are being filed on Form 315; one for Commission consent to the transfer of control of WPNT Media Subsidiary, LLC (“WPNT Subsidiary”), from WPNT to WPNT, LLC (as further explained below), and the other for Commission consent to the transfer of control of MGTF Media Company, LLC (“MGTF Subsidiary”), from MGTF (Old Members) to MGTF (New Members), also as further explained below. The Parties respectfully request that the Commission process both Applications concurrently.

**I. BACKGROUND**

On March 20, 2018, MGTF and WPNT each submitted voluntary petitions for bankruptcy to the United States Bankruptcy Court, Eastern District of Missouri (“Bankruptcy Court”), seeking relief under the provisions of Chapter 11 of the United States Bankruptcy Code to effectuate a restructuring of the debt obligations of each of MGTF and WPNT.<sup>1</sup>

On November 13, 2018, MGTF and WPNT filed the Plan and related Disclosure Statement with the Bankruptcy Court. On January 22, 2019, MGTF and WPNT filed a Supplement to the Plan (“Supplement”). On March 1, 2019, the Bankruptcy Court issued an Order (“Order”) confirming the Plan (as revised by the Supplement). The Order, Plan and Disclosure Statement (and Supplement thereto) are included as Exhibit 7 to this Application.

Since March 20, 2018, each of MGTF and WPNT has been operating its business as a debtor-in-possession under the Bankruptcy Court's oversight.<sup>2</sup>

## II. POST-EMERGENCE STRUCTURE

Under the Plan, the existing senior secured and subordinated debt of WPNT and MGTF will be replaced by a new senior secured credit facility and new equity, which will result in the holder of the new equity obtaining an attributable interest in each of WPNT and MGTF, as reorganized. The new vertical ownership structures of both WPNT and MGTF are set forth on charts that are attached to this Comprehensive Exhibit as *Schedule 1*.

### A. WPNT Structure

Presently, WPNT is owned by four shareholders:

- Saul Frischling (52 percent voting and equity)
- Michael Frischling (16 percent voting and equity)
- Gregg Frischling (16 percent voting and equity)
- Todd Frischling (16 percent voting and equity)

Upon consummation of the Plan, following Commission approval hereof, all equity and voting interests in WPNT shall be transferred to a new holding corporation ("WPNT Holdco, Inc."). WPNT Holdco, Inc. shall establish a new wholly-owned limited liability corporation ("WPNT, LLC").

WPNT then will merge into WPNT, LLC, with WPNT, LLC as the surviving corporation. WPNT Holdco, Inc. will hold 67 percent of the membership interests of WPNT, LLC and will have the right to appoint four persons to serve on the Board of Directors of WPNT, LLC. The remaining 33 percent of the membership interests of WPNT, LLC will be held by 54<sup>th</sup> Street Equity Holdings, Inc. ("54<sup>th</sup> Street"), a wholly-owned subsidiary of Business Development Corporation of America ("BDCA"). BDCA, through 54<sup>th</sup> Street, will have the right to appoint three persons to serve on the Board of Directors of WPNT, LLC. Each member of the Board of WPNT, LLC will have an equal voting share.

BDCA is a closed-end management investment company that has elected to be regulated as a business development company ("BDC") under the Investment Company Act of 1940. Although it is registered with the SEC as a BDC, its shares are not listed and do not trade on any securities exchange. BDCA commenced its initial public offering on January 25, 2011 and closed to new investments on April 30, 2015. Its shares are held primarily by retail investors and may only be purchased by or sold to other persons in private transactions pursuant to an exemption from registration under the Securities Act of 1933. No shareholder holds five percent

or more of BDCA's stock. The business and affairs of BDCA are managed under the direction of BDCA's board of directors. The board of directors has chosen BDCA Adviser, LLC, a subsidiary of Benefit Street Partners LLC ("BSP"), to serve as the company's external manager. As a result, BDCA's investment activities are managed by BDCA Adviser, LLC and supervised by the company's board of directors, a majority of whom are independent of BDCA Adviser, LLC and its affiliates.<sup>3</sup> The board may replace BDCA Adviser, LLC as investment adviser and manager, and thus neither BDCA Adviser, LLC nor BSP are considered to hold an attributable interest in BDCA. WPNT, LLC shall be the sole member of WPNT Subsidiary, and WPNT Subsidiary shall continue to serve as the licensee of the radio stations listed at Section III, Item 2 of the WPNT Application.

Accordingly, upon consummation of the Plan (following Commission approval), the voting control of WPNT, LLC (the sole member of WPNT Subsidiary) will be held by seven persons, each with an equal 14.29 percent voting share: Saul Frischling, Michael Frischling, Gregg Frischling, Todd Frischling and three persons to be appointed by 54<sup>th</sup> Street Equity Holdings, Inc.

#### **B. MGTF Structure**

Presently, MGTF is owned by three individuals, each with equal 33.3 percent membership interests: Michael Frischling, Gregg Frischling and Todd Frischling.

Upon consummation of the Plan, following Commission approval hereof, all membership interests in MGTF shall be transferred to a new holding corporation ("MGTF Holdco, LLC"). MGTF Holdco, LLC will hold 67 percent of the membership interests of MGTF, and will have the right to appoint three persons to serve on the Board of Directors of MGTF. The remaining 33 percent of the membership interests of MGTF will be held by 54<sup>th</sup> Street, and BDCA, through 54<sup>th</sup> Street, will have the right to appoint two persons to serve on the Board of Directors of MGTF. MGTF shall continue to be the sole member of MGTF Subsidiary, and MGTF Subsidiary shall continue to serve as the licensee of the radio stations listed at Section III, Item 2 of the MGTF Application.

Accordingly, upon consummation of the Plan (following Commission approval), the voting control of MGTF (the sole member of MGTF Subsidiary) will be held by five persons, each with an equal 20 percent voting share: Michael Frischling, Gregg Frischling, Todd Frischling and two persons to be appointed by 54<sup>th</sup> Street Equity Holdings, Inc.

### **III. AGREEMENTS FOR THE PROPOSED TRANSFERS OF CONTROL**

A complete copy of the Plan is being submitted with each Application, at Exhibit 7. Also being filed with each Application at Exhibit 7 is a redacted version of the Disclosure Statement and the Supplement. The following exhibits to the Disclosure Statement have been redacted: Exhibit A (Monthly Operating Report); Exhibit B (Liquidation Analysis); and Exhibit C

(Financial Projections). Also being submitted at Exhibit 7 is the Order, as adopted by the Bankruptcy Court.

To the extent that documents relating to the Plan and/or Disclosure Statement are not supplied with this Application (or any future amendment thereto), such documents consist of material that is either proprietary and/or not germane to the Commission's evaluation of this Application. Such information will be provided to the Commission upon request, subject to the parties' rights to submit such material subject to regulations restricting public access to confidential and proprietary information. See *LUJ and Long Nine, Inc.*, 17 FCC Rcd 16980 (File No. BALH-20011011ABJ) (2002) and Public Notice, DA 02-2049, 17 FCC Rcd 16166 (2002). Accordingly, each of Section III, Item 3 and Section IV, Item 5 to each Application have been answered "No."

#### **IV. COMPLIANCE WITH MULTIPLE AND FOREIGN OWNERSHIP RULES**

All of the individual and corporate members of WPNT, LLC and MGTF (as proposed to be reorganized) are U.S. citizens. Neither 54<sup>th</sup> Street Equity Holdings, Inc. nor BDCA holds an attributable interest in any other broadcast station, other than the stations that are the subject of the Applications. Lee Hillman, a director of BDCA, is also a director of HC2 Holdings, Inc. ("HC2"), which has the broadcast interests set out in *Attachment A*. As indicated on *Attachment A*, HC2 does not hold an attributable interest in any radio stations. Consequently, the consummation of the Plan will result in no new radio stations being attributable to WPNT, LLC, MGTF, or any of its members; the only change being proposed is to the ownership structure of the radio stations presently licensed to WPNT Subsidiary and MGTF Subsidiary.

WPNT Subsidiary is the licensee of two FM stations in the Pittsburgh Nielsen Metro. As indicated on the attached BIA Market Report (Pittsburgh), there are far more than four FM stations in that Metro. Accordingly, there are a sufficient number of stations in that market to permit the common ownership by WPNT Subsidiary of two FM stations.

MGTF Subsidiary is the licensee of four FM stations in the Kansas City Nielsen Metro. As indicated on the attached BIA Market Report (Kansas City), there are 45 stations located in the Kansas City Nielsen Metro. Accordingly, there are a sufficient number of stations in that market to permit the common ownership by MGTF Subsidiary of four FM stations. Accordingly, each Application is in compliance with Section 73.3555 of the Commission's rules.

As set forth in greater detail above, Business Development Corporation of America ("BDCA") is a closed-end management investment company that commenced its initial public offering on January 25, 2011 and closed to new investments on April 30, 2015. At the time of the initial public offering and in connection with each new investment, BDCA obtained a subscription agreement from each of its shareholders. In addition, although the investment is relatively illiquid, each time an investor seeks to transfer its stock, the investor must first complete and submit to BDCA a transfer form. Both the subscription agreement and the transfer form require that the investor provide detailed information to BDCA, including, among other things, whether the investor is a U.S. Citizen.

Based upon its analysis of the information regarding the citizenship of the owners of its capital stock, BDCA has concluded that its ownership (calculated on both an equity and voting basis) is in compliance with the limitations on foreign ownership set forth in Section 310(b)(4) of the Communications Act of 1934, as amended.

On a going forward basis, BDCA will continue to collect information regarding the citizenship of its shareholders in order ensure that it maintains compliance with those requirements. To the extent that BDCA receives a transfer form that indicates that a particular foreign shareholder seeks to obtain more than 5% of its capital stock or that its aggregate foreign ownership would exceed 25%, it will withhold its approval of the transfer until any applicable approvals from the FCC are obtained.
