On February 27, 2004, WPME License Corp., a PCC subsidiary, filed an application with the FCC seeking consent to acquire WPME(TV), Portland, Maine (FIN-48408). See FCC File No. BALCT-20040227AAA. This application is presently pending.

On May 5, 2004, Pegasus Satellite Communications, Inc., a PCC subsidiary, filed an application with the FCC seeking consent to acquire WSWB(TV), Scranton, Pennsylvania (FIN-73374). This application is presently pending. See FCC File No. BALCT-20040505AAH.

On May 6, 2004, Pegasus Satellite Communications, Inc., a PCC subsidiary, filed an application with the FCC seeking consent to acquire the construction permit for a new DTV station for Channel 42, Hammond, LA (FIN-83945). See FCC File No. BAPCT-20040506AAU. This application is presently pending.

Furthermore, in the interest of complete disclosure, it is noted that the mother of Marshall Pagon is married to W.W. Keen Butcher, the Chief Executive Officer and Chairman of the Board of Managers of KB Prime Media LLC (“KB Prime”), licensee of WSWB(TV), Scranton, Pennsylvania, WPME(TV), Lewiston, Maine, WTLF(TV), Tallahassee, Florida, and the permittee of DTV Channel 42, Hammond, Louisiana. PCC and its related entities hold an option to acquire any or all of the membership interests and/or assets of KB Prime. This arrangement has been approved by the Commission on two occasions. See FCC File Nos. BAPCT-981116IA and BALCT-980526IA. In addition, PCC or certain subsidiaries provide programming pursuant to local marketing agreements to WSWB(TV), Scranton, Pennsylvania, and WPME(TV), Lewiston, Maine.
