

**AGREEMENT TO ASSIGN
FM TRANSLATOR REBROADCAST
AND OPTION AGREEMENT**

Whereas, High Plains Radio Network (HPRN) has entered into an agreement to purchase all of the broadcast interests of the ARKLAMS radio stations in Greenville Mississippi;

Whereas, A translator, **W247BA**, is currently being operated by ARKLAMS, under terms of that certain agreement of March, 2013, between First Ventures Capital Partners, Inc. (FVCP) the licensee of the translator, and ARKLAMS Radio Group, LLC;

Whereas, HPRN wishes to continue operating the translator as part of the station's operations;

Therefore, It is resolved and agreed to, by all parties below, the following:

HPRN submits that it has read the present rebroadcast and option agreement between ARKLAMS and FVCP, and fully understands the terms, rights and obligations of the agreement.

Further, that HPRN agrees to assume all of the obligations of this agreement, immediately after closing of the ARKLAMS purchase, and will continue making all of the planned payments remaining, and will exercise the Purchase Option, as outlined in paragraph 6 of the agreement.

Further, as is outlined in the agreement, upon exercising this option agreement, and following payment of all monies due to FVCP, FVCP will submit an Assignment Application with the FCC to assign the license of W247BA to HPRN. HPRN agrees full co-operation in execution of it's portion of the assignment of the license to HPRN, and following FCC approval, the license will be transferred to HPRN.




