

TECHNICAL STATEMENT
RADIO MULTIPLE OWNERSHIP ANALYSIS
CLEAR CHANNEL BROADCASTING LICENSES, INC.

This statement and the attached figures were prepared on behalf of Clear Channel Broadcasting Licenses, Inc. ("CCBL"), a licensee subsidiary of Clear Channel Communications, Inc. ("CCC"). CCBL proposes to modify the facilities of WKSJ-FM, Mobile, AL. A multiple ownership analysis was prepared considering the following broadcast stations under present or proposed common ownership, time brokerage or joint sales.¹

Since certain of these stations have overlapping principal community contours (5 mV/m for AM stations, 3.16 mV/m for FM stations), or are located in, or home to, the same Arbitron Metro Markets, an ownership study has been prepared in accordance with the Federal Communications Commission's local radio ownership rule.⁵

CCC does not have an attributable interest in any other station with a principal community contour that overlaps or intersects the principal

community contour of WKSJ-FM as proposed, or which is located in the same Arbitron Metro⁶ as WKSJ-FM. The community of license of WKSJ-FM is located within the Mobile, AL Arbitron Metro, and WKSJ-FM is reported by BIA as being "Home" to that Metro only. Contour overlap of the station to be modified, as depicted in Figure 1, also occurs with commonly-owned stations whose communities of license are located in the nearby Biloxi-Gulfport-Pascagoula, MS, and Fort Walton Beach, FL Arbitron Metro markets.

Arbitron Market Study

WKSJ-FM is reported by BIA as being "Home" to the Mobile, AL Arbitron Metro. This proposal is in compliance with the local radio ownership rules for that Arbitron Metro, as evidenced by Table 2 below:

Interim Contour-Overlap Analysis

Because the principal community of the station to be modified, and the communities of all commonly-owned or attributable stations with overlapping principal contours with the station to be modified are located inside an Arbitron Metro, an interim contour-overlap analysis is not required.

Radio-Television Cross-Ownership Analysis

Because the WKSJ-FM community of license is encompassed within the Grade A contours of commonly owned television stations WPMI-TV, Mobile, Alabama, and WJTC(TV), Pensacola, Florida, a radio-television cross-ownership voice study was conducted in accordance with the provisions of 47 C.F.R. § 73.3555(c). The communities of license of commonly owned FM stations WMXC, WRKH, WTKX and WYCL, as well as the community of license of commonly owned AM station WPMI, are likewise encompassed within the Grade A contours of television stations WPMI-TV and WJTC(TV), for a total of 5 FM, 1 AM, and 2 TV commonly owned stations in the Mobile-Pensacola DMA.

As evidenced by Table 3, there are ten (10) independent television owner voices in the Mobile-Pensacola DMA. Additionally, as evidenced by Table 4, there are 13 additional independent radio owner voices in the Mobile Arbitron metro market, for a total of 23 independent broadcast media owner voices. No new radio or television stations will be commonly owned by CCC or its subsidiaries as a result of this instant application. In markets such as this with at least "20 independently owned voices," a party may have common ownership or attributable interests in up to two television and six radio stations (assuming compliance with the local radio ownership rule). Consequently, CCC's common ownership of 1-AM / 5-FM / 2-TV stations the Mobile-Pensacola DMA complies with the radio-television cross-ownership rule.

Conclusions

In the Arbitron Metro Market studied herein, there are at least 27 radio stations, including the subject commonly-owned 1-AM / 3-FM stations, which are home to the Mobile, AL Arbitron Metro; consequently, common ownership of 1-AM / 3-FM stations complies with the local radio ownership rule. This proposal does not affect the existing number of commonly-owned radio stations in the subject Arbitron Metro.

In the Mobile-Pensacola DMA, there are at least 20 independently owned media voices; consequently, common ownership of 1-AM / 5-FM / 2-TV stations complies with the radio-television cross-ownership rule. This proposal does not affect the existing number of commonly-owned broadcast stations in the subject DMA.

Based on the above, it is concluded that the proposed modification complies with Section 73.3555 of the FCC Rules.
