Zimmer Radio of Mid-Missouri, Inc. (“ZRMM”) currently is the sole shareholder of ZRI. Jerome R. Zimmer, John P. Zimmer, and James L. Zimmer are the voting shareholders, officers, and directors of ZRMM. ZRI is the licensee of the following radio broadcast stations.

The instant application requests Commission consent for the assignment of the licenses for the above-listed stations from Zimco to ZRI. Concurrently with this application, ZRI is filing an application to transfer control of ZRI from ZRMM to the James R. Zimmer Revocable Trust U/A/D October 14, 1997, of which James R. Zimmer is the sole trustee. Also concurrently with this application, ZRMM is filing an application for a transfer of control of ZRMM that will, among other things, eliminate James L. Zimmer’s interests in ZRMM. Thus, upon the consummation of the proposed transfer of control of ZRI and the proposed transfer of control of ZRMM, there will be no common ownership between ZRI and ZRMM.

Upon the consummation of the proposed transfer of control of ZRI to the James R. Zimmer Revocable Trust U/A/D October 14, 1997, there will be no common ownership between Jayhawk Broadcasting, Inc. and ZRI.
