Dear Ms. Dortch:

Calvary Radio Network, Inc. (“CRN”), licensee of FM Translator Station W264BF, Englewood, IL, through its attorney, hereby responds to a letter dated January 25, 2017 from James D. Bradshaw, Deputy Chief, Audio Division, Mass Media Bureau. That letter referenced interference complaints filed by NM License, LLC (“NM License”), alleging that W264BF is interfering with the reception of WRXQ, Coal City, IL, and required CRN to submit a detailed report on those complaints.

On or about January 30, 2017, CRN reduced W264BF’s power from 10 watts to 6 watts using the current antenna. Then, on January 31, 2017, CRN mailed a letter and questionnaire (the “Questionnaire”), in the form attached hereto as Exhibit A, via USPS First Class Priority Mail with Tracking to the twenty-nine (29) complainants identified in NM License’s complaints. Twenty-four (24) of the Questionnaires were delivered on February 4, 2017, one was delivered on February 6, 2017, and one was delivered on February 7, 2017. Two of the Questionnaires are still listed as being “in transit,” although we received a completed Questionnaire from one of these recipients.<sup>1</sup>

One of the Questionnaires was returned as undeliverable.<sup>2</sup> A copy of the tracking information for each Questionnaire is attached hereto as Exhibit B.

The complainants were given a deadline of February 17, 2017, to complete and return the Questionnaires. As of the date of this filing, we have received responses from five (5) complainants, all attached hereto as Exhibit C. The remaining twenty-three (23) complainants (excluding the complainant whose Questionnaire was returned as undeliverable) did not respond, resolving CRN of any further responsibility with respect to these complainants. *See, e.g., Letter from James D. Bradshaw to Robert J. Rim, Counsel to Columbia Bible College Broadcasting Company, and Arthur S. Landerholm, Counsel to Family Worship Center Church, Inc., 2002 WL 35073263 (Apr. 8, 2002).*

The first of the five responses we received was from Philip Smith. Mr. Smith's response was received via email on February 12, 2017. In his response, Mr. Smith provides that he is "not faxing the entire form because the level of interference has dropped significantly," and that "[d]uring [his] daily commute, it is almost completely gone."

The second response, from John Cegielski, was received on February 13, 2017. As an initial matter, Mr. Cegielski's response contains an internal inconsistency. He states that he started listening to WRXQ in January 2016, but that he first noticed he was having trouble picking up the signal of WRXQ in February 2015. Additionally, the Questionnaire was mailed to Mr. Cegielski at the address provided in his original complaint, which was made part of NM License's Second Supplement to Reply to Opposition to Informal Objection, filed May 11, 2017. As stated in footnote 1, above, the USPS tracking system still shows Mr. Cegielski's Questionnaire as being "in transit" as of February 8, 2017. The address Mr. Cegielski provided in his response to the Questionnaire, however, is different from the address Mr. Cegielski originally provided and to which the Questionnaire was mailed, which begs the question of whether Mr. Cegielski may fairly be deemed a regular listener at his new address in Woodridge. We tried to clarify this and other matters by calling Mr. Cegielski at the number provided on his completed Questionnaire, but all such attempts were unsuccessful. See Declaration of Ashley Ludlow, attached hereto as Exhibit D.

Colleen La Fleur's response was also received on February 13, 2017. Ms. La Fleur's response, however, did not contain any of the requested information on the specific radio device(s) receiving the interference (*i.e.*, type of device, manufacturer's name, model number, and serial number). Several follow-up attempts were made to reach out to Ms. La Fleur, though these too have been unsuccessful. See Declaration of Ashley Ludlow, attached hereto as Exhibit D.

The fourth response was received on February 15, 2017, and was from Karl Kopija. Mr. Kopija noted that his WRXQ reception at his home in Joliet has improved. He did, however, note



that he was still receiving interference in his car. A follow-up call was made to Mr. Kopija on February 21, 2017, during which Mr. Kopija stated that his WRXQ reception at home had improved significantly. He stated that interference while driving had much improved and that he was unsure whether he was within the range of WRXQ's signal in those areas where he was still receiving interference. Mr. Kopija has provided an email verifying these statements, attached hereto as Exhibit E. Notably, Mr. Kopija states that his reception of WRXQ at home has "improved to the point where [he] seem[s] to have no interference on any device in the home in any weather."

The fifth and final response was from Sandy Wheeler. Ms. Wheeler's response was dated February 8, but was not received until February 22, 2017. A follow-up call was made to Ms. Wheeler on February 22, at which point she stated that she had not had an opportunity to listen to WRXQ recently to determine whether there had been a change in her reception of the station. She provided an email verifying this fact on February 23, 2017, attached hereto as Exhibit F.

CRN will continue to work with these complainants to ensure any interference to their reception of WRXQ caused by W264BF is eliminated. CRN is exploring changing the antenna and the mounting of the antenna in hopes that doing so may eliminate any interference to WRXQ.

I am writing on behalf of Calvary Radio Network, Inc. (“CRN”), the owner of FM translator W264BF, which operates on 100.7 MHz from the Willis Tower in Chicago.

It is my understanding that you have notified radio station WRXQ, Coal City, Illinois, that you are a WRXQ listener, and that you have had problems receiving WRXQ under certain circumstances.

WRXQ has submitted to the Federal Communications Commission in Washington, D.C., a declaration signed by you alleging that W264BF is interfering with your reception of WRXQ.

CRN has made technical adjustments to the translator’s facilities and wants to know if you are still experiencing any interference from W264BF to your reception of WRXQ. I will provide some detail that was on your form. However, I am not faxing the entire form because the level of interference has dropped significantly. During my daily commute, it is almost completely gone.

I began listening to WRXQ in February 2003, and have been a regular listener since that time. I originally listened every day of the week, but once the interference began, my listening dropped to about 3 days per week.

I drive between my hometown of Beecher, to and from my work location at Applied Pkwy in University Park, most often using Crete-Monee Road or Exchange Street along the commute. I also shop in the Matteson, Frankfort, Tinley Park, and Orland Park areas relatively often. In 2008 the interference with WRXQ began, with background noise and pops, and occasional flipping to a religious station, along my work commute. At my place of work, some areas of the parking lot allowed me to hear the interfering station which after several months and trips up I-57 to Chicago, I identified as a religious station clearly transmitting from downtown Chicago. I actually began to favor a more southern route to work on days when I wanted to listen to WRXQ, because the interference was too annoying on the more northern routes. Driving through Matteson, WRXQ was getting very heavily interfered with, and in the Orland Park area the religious station was predominant, with WRXQ now sounding more like the interfering station. In all these locations I was able to identify Calvary Radio Network as the source of the interference, in my prior car which was a 2002 Pontiac Grand Prix with stock receiver, and in my 2012 Hyundai Tucson with stock receiver.

At my home in Beecher, I noticed that in some rooms in my two-story home, on a portable Sangean ATS-909X radio, I had trouble getting a clear signal in stereo for WRXQ. In these same locations, by rotating the antenna just right, I was able to hear the Calvary Radio station. However, I did not consider this interference to be as annoying, since I could rotate the antenna to reduce or eliminate it.

After years of dealing with the interference, I searched online to see if there was some way to file a complaint. When I went to the Q-Rock 100.7 (WRXQ) web site, I saw a location on their site to file a formal complaint, so I did. Nobody from the station contacted me regarding this.

Since sometime in January, I noticed that WRXQ became mostly free of interference along my commute between Beecher and University Park. I've been listening more often to WRXQ as a result. In Matteson, WRXQ became listenable for me again, with only very sparse occurrences where Calvary Radio can be heard. I have

not been in the Tinley Park, Orland Park or Frankfort areas since this interference has been reduced -- but these are not my primary areas of concern.

I appreciate the work your client has done to help rectify the problem.





## DECLARATION

I, Ashley Ludlow, do hereby declare under penalty of perjury:


1. I am an Associate Attorney at the law firm of Fletcher, Heald & Hildreth, PLC (“FHH”).
2. On January 31, 2017, I mailed, via USPS First Class Priority Mail with Tracking, Questionnaires to the twenty-nine (29) complainants identified in NM License’s complaints.
3. Based on USPS tracking information, twenty-four of the Questionnaires were delivered on February 4, 2017, one was delivered on February 6, 2017, and one was delivered on February 7, 2017. Two of the Questionnaires are still listed as being “in transit,” although FHH did receive a completed Questionnaire from one of those complainants (from John Cegielski, discussed below). One of the Questionnaires – that addressed to Kevin Strong – was returned as undeliverable. Mr. Strong’s address conforms to that which he provided in his original complaint, which was made part of NM License’s Second Supplement to Reply to Opposition to Informal Objection, filed May 11, 2017 (the “Second Supplement”).
4. The complainants were given a deadline of February 17, 2017, to complete and return the Questionnaires. As of the date of this Declaration, FHH has received responses from five (5) complainants. The remaining twenty-three complainants (excluding Mr. Strong) did not respond.
5. The first of the five responses FHH received was from Philip Smith. His response was received via email on February 12, 2017. Because Mr. Smith provided that the level of interference had “dropped significantly,” no further attempts were made to reach out to Mr. Smith.
6. FHH received a completed Questionnaire from John Cegielski on February 13, 2017. The telephone number Mr. Cegielski provided in his response is illegible. Unable to decipher the number, I tried calling several possible variations of the number, first, on February 21, 2017, at a number I initially read as (630) 310-8704. That number was not in service. I then compared the number in Mr. Cegielski’s completed Questionnaire to that provided in his original complaint, which was made part of NM License’s Second Supplement. Still unable to decipher the number, I called and left voicemails on February 21, 2017, for the following two numbers: (630) 390-8709 and (630) 390-8704. The former number, ending in 8709, had an answering machine for an individual by the name of Dr. Dan Costa. The latter number, ending in 8704, had an automated answering machine which provided no identifiable information. I have not received a call from any of these numbers to date.

7. FHH also received Collen La Fleur's completed Questionnaire on February 13, 2017. I left a voicemail for Ms. La Fleur at the number provided in her response on February 21, 2017, and again on February 22, 2017. Ms. La Fleur has not returned my calls to date.

8. The fourth response was received on February 15, 2017, and was from Karl Kopija. I called and left a voicemail for Mr. Kopija on February 21, 2017. He returned my call within the hour and stated that the interference to his reception of WRXQ had much improved. Mr. Kopija followed up with an email dated February 22, 2017, confirming these statements.

9. FHH received the fifth and final response, which was from Sandy Wheeler, on February 22, 2017. I called Ms. Wheeler that day, during which conversation she stated that she had not had an opportunity to listen to WRXQ recently to determine whether there had been a change in her reception of the station. She provided an email verifying this fact on February 23, 2017.

This e-mail is to document and confirm our discussion Tuesday 2/21/2017 pertaining to my experience with interference issues with the radio station WRXQ 100.7 FM Joliet Il.

Please keep in mind that I am not a broadcasting engineer or technician and do not fully understand the nature of FM radio signal interference. I also do not have a knowledge of how far the WRXQ signal is legally intended to broadcast so if I mention locations with issues that are legally out of range please excuse any misunderstanding on my part.

I will start by saying that at least in the last two weeks my home signal of WRXQ at 18165 Gougar RD Joliet Il 60432 has in fact improved to the point where I seem to have no interference on any device in the home in any weather. I had previously had static and fade issues that worsened with cloudy and rainy weather.

I do however still have fade, static, and sometimes complete change of station at these locations when driving in any of my cars

1. I355 and 127th street Lemont Il while travelling either north or south.
2. 159th and Will Cook Road, Homer Glen? Signal begins to return when heading West on 159th at about Bell Road.
3. I noticed since our conversation that I also have issues on 151st ST and Gougar RD
4. And also I 57 North of Monee Manhattan RD

Locations 1 and 2 have static and fade plus I can occasionally hear the CRN broadcast, 3 and 4 are just fade and static.

When I originally responded to a WRXQ broadcast request for listeners to write to the station regarding bad signal quality I had not understood that it was due to interference with any other radio station. The station never told me at any time that the reason for interference was due to another station. I have merely relayed my actual experiences in the hope of getting a better signal overall with a greater geographic reach.
