Dear Mr. Perry:

This is in reference to the request filed October 11, 2006<sup>1</sup>, on behalf of United Broadcasting Company, Inc. ("UBC"). UBC requests reinstatement and further extension of the Special Temporary Authority ("STA") originally granted on April 10, 1997, for operation of Station KTKK<sup>2</sup> from the licensed site of Station KLLB, West Jordan, Utah.

In support of the request, UBC states that, after its attempts to locate a new, permanent site for the station were unsuccessful, it has filed major change Application BMJP-20040130AWS, to change the city of license to Kearns, Utah. UBC states that its application remains pending.

We note that the previous STA expired on January 20, 2005. Our review indicates that the circumstances presented warrant grant of STA in order to provide for service to the public, and that the requested STA facilities are the same as were previously authorized. However, in light of the lapse of time between the expiration of the prior STA and the filing of the instant request, it will be considered as a request for a new STA; the authority granted will not cover the period between the expiration of the prior STA and the filing of the instant request.

Accordingly, the request for STA IS HEREBY GRANTED. Station KTKK may operate with the following facilities:

Geographic coordinates: 40° 33' 06" N, 111° 58' 17" W (NAD 1927)

<sup>1</sup> For reasons which are not readily apparent, the request was not received by Audio Division staff for processing until January 31, 2007.

<sup>2</sup> Station KTKK is licensed (BL-800129AB) to Sandy, UT, for operation on 630 kHz at geographic coordinates 40° 41' 30" NL, 111° 55' 30" WL, with power of 1.0 kW daytime and 0.5 kW nighttime, employing different directional antenna patterns day and night (DA-2).

Hours of operation:	Unlimited
Operating power:	Not to exceed 1 kW daytime, 0.051 kW nighttime
Antenna type:	licensed tower of Station KLLB, West Jordan, Utah

It will be necessary to reduce power or cease operation if complaints of interference are received. Appropriate measures shall be taken to protect the public and workers from the exposure to radiofrequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR §§ 1.1307, 1.1310. The authority granted herein does not cover the period between January 20, 2005, and October 11, 2006, and is without prejudice as to whatever action the Commission may take with respect to operation of Station KTKK during the foregoing period.

This authority expires on **August 14, 2007**.
