³ On March 13, 2013, the Commission granted an application on FCC Form 316 for consent to the *pro forma* transfer of control of Nexstar Broadcasting Group, Inc. See lead File No. BTCCDT-20130301ACO. That grant consented to the “downgrading” of the control exercised over Nexstar by ABRY Broadcast Partners II, L.P. and ABRY Broadcast Partners III, L.P. (collectively, “ABRY”), the principal shareholders of NBGI, from *de jure* to *de facto*. On May 1, 2013, ABRY initiated the sale of their shares in the public market, which sale is anticipated to be completed on May 7, 2013. Accordingly, this exhibit is being submitted assuming completion of the sale and the consummation of the *pro forma* transfer of control of Nexstar on May 7, 2013.

⁴ Certain of the officers and directors (other than Mr. Sook) collectively hold approximately 0.6% of votes and assets.

⁵ Upon completion of the ABRY sale on May 7, 2013, Nexstar will assess NBGI’s public shareholders and, if necessary, submit an amendment to this application disclosing shareholders of NBGI that hold a cognizable voting share of NBGI of 5% or greater (or 20% or greater for investment companies, as defined in 15 U.S.C. 80a–3, insurance companies and banks holding stock through their trust departments in trust accounts).
