


Note that a few additional tracts were also examined but ruled out at the beginning because of one or more conflicts. Out of the above, three (3) property owners refused to even talk selling, three (3) others did not answer letters mailed to them. We have been unable to locate a telephone number for the majority of the rest as all searches produce either no number, or numbers which have been changed or disconnected. The County Tax Assessor's office has only mailing addresses. A drive through the preferred geographical areas where an alternate site might be located was ineffective as no 'for sale' signs were observed. Representatives of two different branches of local County Government were also unable to locate suitable sites.

It became quite evident there was virtually no likelihood of buying a technically suitable property, surveying, permitting, clearing and grading and erecting a tower during winter weather and being ready for testing and on air by the limited time period of August next year. Therefore, a decision was made to apply different engineering variables to meet 'first service requirements' for a site where an Option to Buy was already in place.

Expedited processing and waiver of Section 73.7002 (c) is respectfully requested as Spirit has reduced the 'loss' to less than one percent or *de minimis* as is illustrated in detail by *precedence* in the accompanying engineering exhibits.


