On July 29, 2019, the Media Bureau approved applications for TEGNA Inc. to assume control of the licensees of WTHR(TV), Indianapolis, IN; WALV-CD, Indianapolis, IN; WBNS-TV, Columbus, OH; and WBNS-AM/FM, Columbus, OH. *See* File Nos. BTCCDT-20190617AAR, BTCCDT-20190617AAS, BTCH-20190617AAT, and BTC-20190617AAV. Those transfers of control are awaiting consummation.

Applications currently are pending in which TEGNA or designated subsidiaries thereof propose to acquire the licenses of 11 full-power television stations being divested in connection with the proposed Nexstar/Tribune transaction. *See Media Bureau Accepts for Filing Divestiture Applications in Proceeding to Transfer Control of Tribune Media Company to Nexstar Media Group, Inc., and Establishes Consolidated Pleading Cycle*, Public Notice, MB Docket No. 19-30, DA 19-341, at Attachment A (MB April 26, 2019). None of these pending applications involves any station licensed to a community in the Tucson DMA.
