**Parties to the Application**

This application seeks FCC consent to the transfer of control of NewsChannel 5 Network, LLC to Bonten Media Group Inc. (“Transferee”). The Transferee is a wholly-owned subsidiary of Bonten Media Group Holdings, Inc., which in turn is controlled by Bonten Media Group, LLC (“Bonten Media Group”). Two of Bonten Media Group’s members – Diamond Castle Partners IV, L.P. and Bonten/Diamond Castle, LLC – are controlled, directly or indirectly, by DCP IV GP, L.P. Diamond Castle Partners IV, L.P. has the right to designate at least a majority of the members of the governing Management Committee of Bonten Media Group. As a consequence, Diamond Castle Partners IV, L.P., through its general partner DCP IV GP, L.P., holds the power to exercise control of the Transferee.

There are no parties to this application with attributable status as a result of the operation of the Commission’s “equity-debt plus” rule (47 C.F.R. §73.355, Note 2(j)). Ownership information for the Transferee and those entities with attributable interests in the Transferee is set forth below.
