


Figure 2 – Section 74.1204 Study Closeup to WAAF

Figures 1 and 2 illustrate the absence of prohibited overlap between the proposed translator interfering contours and the pertinent service contour of each facility. (Key: Same colors may not overlap.)

No overlap exists with W246BP at Exeter, NH, for which WXEX(AM) is also primary. The authorized and proposed service contours (green and thin green) overlap.

Environmental Considerations

The proposed antenna will be mounted on an existing tower. The site is fenced and inaccessible to the general public, and marked with appropriate RFR warning signs. The applicant will cease operation or reduce power as necessary in order to prevent uncontrolled or controlled exposure in excess of the guidelines of OET-65.

There is no overlap with W246BP (light green), for which WXEX(AM) is also primary.
