Schedule I – This schedule lists the tangible personal property to be assigned. The information in this schedule does not reflect on the legal or other qualifications of the parties and is not relevant to whether the structure of the transaction complies with the FCC’s rules.

Schedule 1.2(f) – This schedule lists certain contracts to be excluded from the transaction. The information in this schedule does not reflect on the legal or other qualifications of the parties and is not relevant to whether the structure of the transaction complies with the FCC’s rules.

Schedule 3.3 – This schedule lists any conflicting agreements or agreements for which consent is required under the Agreement. The information in this schedule does not reflect on the legal or other qualifications of the parties and is not relevant to whether the structure of the transaction complies with the FCC’s rules.

Schedule 3.4 – This schedule lists any exceptions to ownership of the tangible personal property being assigned.
