Double O South Carolina Corporation ("DOSCC"), the proposed assignee under the instant application, is the permittee of a construction permit for an FM station to serve Forest Acres, SC (FIN: 83396). That permit has been assigned call sign "WWNQ."

Pilot Group LP, an indirect parent company of Double O, is the sole member of Barrington Broadcasting LLC, which is the sole shareholder of Barrington Broadcasting Corporation, which is the sole shareholder of: Barrington Broadcasting Quincy Corporation, the licensee of KHQA-TV, Hannibal, MO (FIN: 4690); Barrington Broadcasting Peoria Corporation, the licensee of WHOI(TV), Peoria, IL (FIN: 6866); and Barrington Broadcasting Flint Corporation, the licensee of WEYI-TV, Saginaw, MI (FIN: 72052). In addition, Barrington Broadcasting LLC is also the sole shareholder of Barrington Michigan Corporation ("BMC"), which has reached an agreement with ACME Communications, LLC ("ACME") to acquire the construction permit for a new television station that will operate on Channel 46 in Bay City, Michigan (FIN: 82627). BMC understands that ACME has reached an agreement with Vista Communications, Inc. ("Vista"), the permittee of that new station, under which ACME will first acquire the permit from Vista.
