

### **Television Duopoly Analysis**

Section 73.3555(b)(2) of the Commission's rules permits common ownership of two full-power television stations licensed in the same DMA, the Grade B or digital noise-limited contours of which overlap, provided that, at the time the application to acquire the station(s) is filed: (1) at least one of the two stations is not ranked among the top four stations in the DMA, based on the most recent all-day audience share; and (2) at least eight independently owned and operating, full-power commercial and noncommercial television stations would remain in the DMA after the merger.

As demonstrated in the attached 2014 year-end Nielsen report of the top 50 television programs in Puerto Rico for the year, there are really only 3 major television stations in Puerto Rico, all of which are licensed to the San Juan metropolitan area: WAPA, an independent station; WKAQ, the Telemundo affiliate; and WLII-DT, the Univision affiliate. Each of these stations, as explained in other exhibits to this application, have their own satellite and rebroadcast agreements with stations around the island.

Neither of the proposed duopoly stations here – WSJU-TV or WCTV-TV, ranks in the top four television stations in the San Juan metro or the Puerto Rico DMA as a whole. WCTV-TV broadcasts several digital streams of programming to its audience, the primary stream carrying MegaTV, a Spanish-language network produced by Spanish Broadcasting System, Inc. MegaTV is, in comparison with the dominant Spanish-language broadcasting networks Univision and Telemundo, a fledgling Spanish-language network with affiliate stations broadcasting on mostly low-power TV stations in a handful of cities in the United States and Puerto Rico. WSJU-TV, by contrast, airs TiVA TV, which airs programming developed by a local doctor promoting healthy living, natural remedies, and recreational activities in Puerto Rico.

As shown in the attached screen-display from CDBS, there are a total of 34 full-power television stations licensed to Puerto Rico. Even if you disregard the stations outside of the San Juan metro that operate as satellites or repeaters of San Juan stations, there are 20 independent full-service full-power television stations serving Puerto Rico (inclusive of WSJU and WTCV). A further analysis of the full-power TV stations in Puerto Rico with information as to network affiliation and/or satellite/rebroadcast status follows the CDBS page.

Finally, Engineer Grafton Olivera has prepared a contour map of the stations licensed to the San Juan metro area, which demonstrates that there will be 13 independent full-power TV stations serving that submarket of the island where WTCV and WSJU are located.

Because neither station is ranked among the top four stations in Puerto Rico, and because the market will still have well over the minimum of eight independent full-power television stations serving the market after the proposed transfer, the Commission should permit the proposed television duopoly.

## Television Ownership

The proposed transferees will have interests in four commercial television stations, two of which are satellite stations, as discussed in a later section, and are therefore not subject to the multiple ownership rules per Note 5 to 73.3555.

Both WTCV and WSJU-TV are licensed to San Juan, Puerto Rico. An entity may directly or indirectly own, operate, or control two television stations licensed in the same DMA if at least one of the stations is not ranked among the top four stations in the DMA, as measured by Nielsen Media Research, or any comparable professional, accepted audience ratings service; and at least eight (8) independently owned and operating, full-power commercial and noncommercial TV Stations remain post-merger in the DMA in which the communities of license of the TV stations are located. Pursuant to Note 4 to §73.3555, this rule will not be applied to applications for assignment of license or transfer of control to heirs or legates by will or intestacy, if no new or increased concentration of ownership will be created.

Upon consummation of the proposed transaction, there will be thirteen independent full-power commercial and non-commercial TV stations, in addition to WTCV and WSJU-TV, whose noise-limited contours<sup>1</sup>, are depicted in Figure 4, encompass the community of San Juan, Puerto Rico. These thirteen digital television stations will be licensed to the following entities:

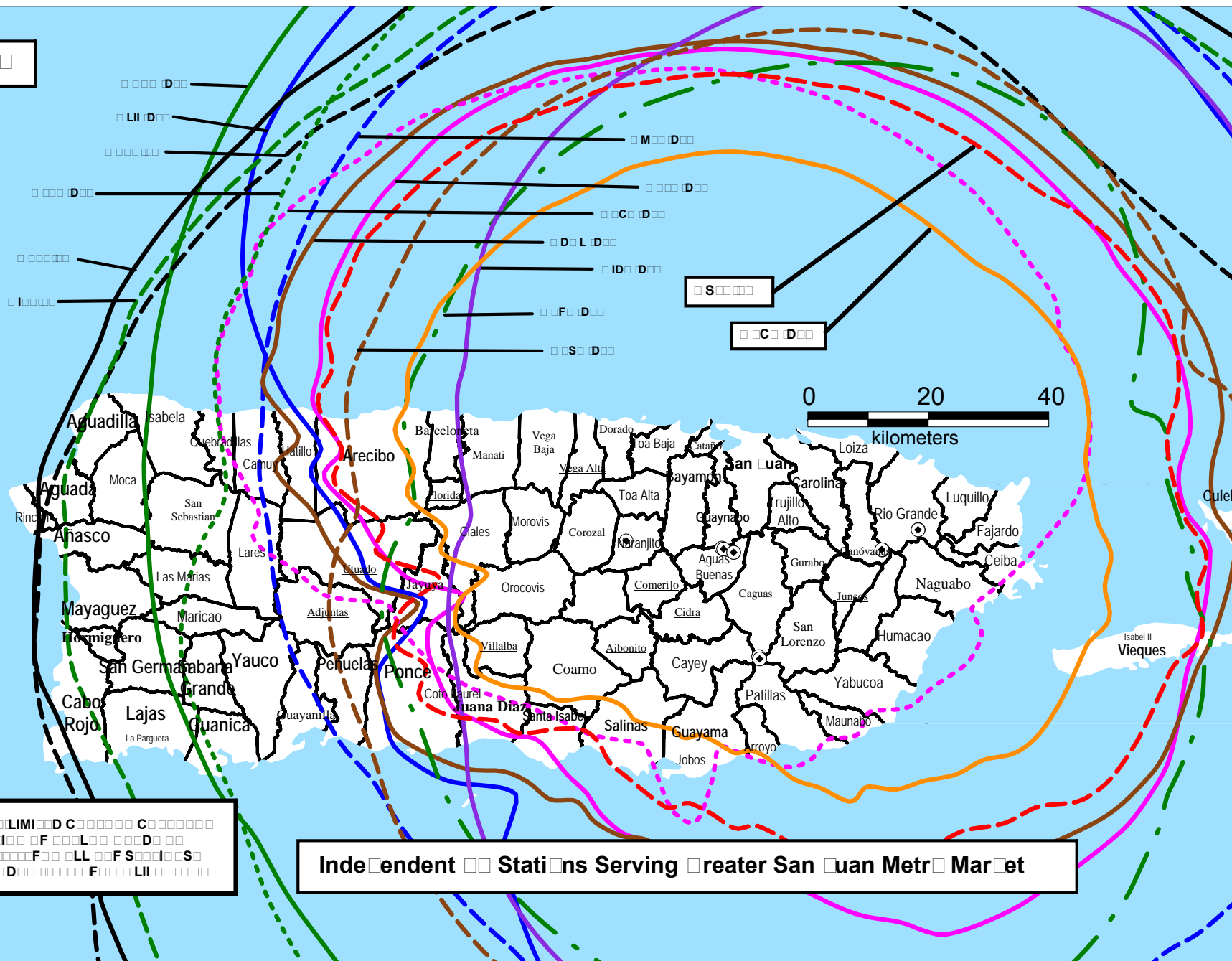

At least fourteen (14) independently owned and operating, full-power commercial and noncommercial TV Stations with a primary contour that encompasses the community of San Juan, Puerto Rico, will remain post-merger. Additionally, according to Nielsen Rankers, which provides television program ratings for the island of Puerto Rico, at least one of the two stations sought to be commonly-owned is not among the top four rated stations in the market.
