


**UNANIMOUS WRITTEN CONSENT
IN LIEU OF A MEETING OF THE BOARD OF DIRECTORS
OF
PAPPAS TELECASTING INCORPORATED**

The undersigned, being all of the directors of Pappas Telecasting Incorporated, a California corporation (the "Corporation"), hereby consent to the taking of the following actions by unanimous written consent in lieu of a meeting and hereby adopt the following resolutions and each and every action effected thereby:

Chapter 11 Filing

WHEREAS, the Board of Directors of the Corporation has been presented with a proposed petition to be filed by the Corporation in the United States Bankruptcy Court for the District of Delaware seeking relief under the provisions of chapter 11 of title 11 of the United States Code (the "Bankruptcy Code"), in which the authority to operate as a debtor-in-possession will be sought, and has determined that it is in the best interests of the Corporation and its stockholders that the Corporation file such a petition;

WHEREAS, the Corporation is the sole member of KMPH (TV) License, LLC, a Delaware limited liability company (the "Pappas LLC"); and

WHEREAS, the Corporation, as the sole member of the Pappas LLC, has been presented with a proposed petition to be filed by the Pappas LLC in the United States Bankruptcy Court for the District of Delaware seeking relief under the provisions of chapter 11 of title 11 of the Bankruptcy Code, in which the authority to operate as a debtor-in-possession will be sought, and has determined that it is in the best interests of the Pappas LLC and its sole member that the Pappas LLC file such a petition.

NOW THEREFORE, BE IT RESOLVED, that both the Corporation and the Pappas LLC file petitions seeking relief under the provisions of chapter 11 of title 11 of the Bankruptcy Code, in which the authority to operate as a debtor-in-possession will be sought, and the filing of such petitions hereby is authorized;

RESOLVED FURTHER, that each of the Chairman, President, and Chief Executive Officer of the Corporation hereby are appointed by the Board of Directors as an authorized signatory (each, individually, an "Authorized Officer," and, collectively, the "Authorized Officers") in connection with the chapter 11 cases authorized herein;

RESOLVED FURTHER, that the Authorized Officers hereby are, or any one of them, and each of them hereby is, authorized, empowered and directed on behalf of the Corporation and the Pappas LLC to execute and verify petitions in the name of the Corporation and the Pappas LLC under chapter 11 of the Bankruptcy Code and to cause the same to be filed in such form and at such time as the Authorized Officer executing said petition on behalf of the Corporation and the Pappas LLC shall determine;

RESOLVED FURTHER, that the Authorized Officers hereby are, or any one of them, and each hereby is, authorized to execute and file or cause to be executed and filed (or to direct others to do so on their behalf as provided herein) all necessary documents, including, without limitation, all petitions, affidavits, schedules, motions, lists, applications, pleadings and other papers, and in that connection to employ and retain assistance of legal counsel, accountants or other professionals and to take any and all other action which they or any one of them deem necessary, proper or desirable in connection with the chapter 11 cases contemplated hereby, with a view to the successful prosecution of such cases; and

RESOLVED FURTHER, that all acts lawfully done or actions lawfully taken by the Authorized Officers or any other officers of the Corporation and the Pappas LLC to seek relief under chapter 11 of the Bankruptcy Code or in connection with the chapter 11 cases, or any matter related thereto, hereby are adopted, ratified, confirmed and approved in all respects as the acts and deeds of the Corporation and the Pappas LLC.

Appointment of Professionals

RESOLVED, that the law firm of Kaye Scholer LLC and its affiliates hereby are employed under general retainer as attorneys for the Corporation and the Pappas LLC in the chapter 11 cases on such terms as the Authorized Officers shall approve;

RESOLVED FURTHER, that Moelis & Co. hereby is employed as financial advisor and investment banker for the Corporation and the Pappas LLC in the chapter 11 cases on such terms as the Authorized Officers shall approve;

RESOLVED FURTHER, that M. Green and Company LLP hereby is employed as certified public accountants for the Corporation and the Pappas LLC in the chapter 11 cases on such terms as the Authorized Officers shall approve;

RESOLVED FURTHER, that the law firm of Koley Jessen P.C., L.L.O. hereby is employed under general retainer as special counsel for the Corporation and the Pappas LLC in the chapter 11 cases on such terms as the Authorized Officers shall approve;

RESOLVED FURTHER, that the law firm of Pachulski Stang Ziehl & Jones LLP hereby is employed under general retainer as local counsel for the Corporation and the Pappas LLC in the chapter 11 cases on such terms as the Authorized Officers shall approve; and

RESOLVED FURTHER, that the Corporation and the Pappas LLC are hereby authorized to hire any other professionals to assist with the chapter 11 cases authorized herein on such terms as the Authorized Officers shall approve.


