

SETTLEMENT AGREEMENT

This Agreement is made and entered into by and between Caguas Educational TV, Inc. ("Caguas") and Florida Public Radio, Inc. ("Florida Public").

WITNESSETH

WHEREAS, Caguas (File No. BMPED-19951011MK) is prosecuting an application before the Federal Communications Commission ("FCC") for a minor change in the licensed facilities of noncommercial educational radio station WLAZ (FM), Kissimmee, Florida;

WHEREAS, Florida Public (File No. BMPED-19950629ID) is prosecuting an application before the FCC for a minor change in the licensed facilities of noncommercial educational radio station WPIO(FM), Titusville, Florida;

WHEREAS, the foregoing applications are mutually exclusive with one another;

WHEREAS, the parties believe that it is in the public interest to reach a settlement regarding the above referenced mutually-exclusive applications and to provide for the prompt initiation of improved and new service to the citizens in and around Kissimmee and a Titusville, Florida;

NOW THEREFORE, in consideration of the mutual covenants herein made each to the other and intending to be legally bound thereby, the parties agree as follows:

1. Modification of applications. Subject to the conditions set out herein and the approval of this agreement in its entirety by the FCC, Caguas and Florida Public agree,

pursuant to Section 73.3525 of the FCC's Rules, to modify their applications, referenced above, to the degree necessary to eliminate the mutual exclusivity that currently exists.

2. No Consideration. Neither Caguas nor Florida Public has paid, or promised to pay, any consideration or other thing of value in exchange for modifying its own application or in exchange for the modification by the other party of its pending application, both of which are referenced above.

3. FCC Approval. If the FCC grants one application, but fails to grant the other, this agreement shall remain in effect, and neither party shall file a subsequent application to modify its facilities until such time as both applications have been granted by the FCC.

4. Cooperation of Parties. Should the FCC refuse to approve this Agreement, the undersigned parties hereby agree that they will immediately make good faith efforts to resolve each FCC (or judicial) objection in order to obtain FCC or judicial approval. The parties further agree to take no action inconsistent with the purposes of this Agreement.

5. Benefit. This Agreement shall inure to the benefit of and be binding upon the parties hereto, their successors and assigns.

6. Execution. This Agreement may be executed in counterparts and facsimile signatures shall be acceptable.

8. Notices. Any Notices required by this Agreement shall be effective if sent by certified mail, return receipt requested, postage paid as follows:


