## **Settlement Agreement-Time Share-Aggregated Points**

Reach For The Top, Inc. ("Venice") and Strategic International Ministries ("Simi") (collectively "99.1 applicants") have reached a mutual partial settlement agreement regarding the use of Channel 256L1 in the Los Angeles area.

This *Partial Settlement Agreement* was designed in a manner that would most efficiently use Channel 256L1 in Los Angeles. Neither party is proposing simultaneous operation. As both of the applicants are in the same MX group and none are proposing a channel change as a part of this partial settlement agreement, the points for these applicants can be aggregated and as a result, the 99.1 applicants can claim a combined 10 points.

## **FINDINGS**

A settlement agreement has been reached between the 99.1 applicants in the above captioned proceeding.

The 99.1 applicants have determined it would be in the public interest to enter into this partial settlement agreement in accordance with §73.872(c) of the Commission's Rules. This settlement represents a group of two applicants that agree that acceptance of this partial settlement would serve the objectives of the Communications Act of 1934, as amended as well as the rules and policies of the Commission. In addition, the settlement will conserve Commission resources, promote spectrum efficiency, promote localism and will result in the expedited implementation of the proposed LPFM stations.

None of the 99.1 applicants filed their applications for the purpose of reaching or carrying out such an agreement.

The settlement agreements agreed into by the parties contain the entire understandings and undertakings between the parties pertaining to these matters.

The undersigned ask that the Commission accept this partial settlement agreement with an aggregated score of 10 points.




