- 1 During equipment tests, the permittee shall take adequate measures to identify and eliminate objectionable interference that may be caused to existing land mobile radio facilities in the 460-470 MHz band (or 806-816 MHz band) authorized prior to the date this construction permit is issued. Documentation that objectionable interference will not be caused to existing land mobile radio facilities shall be submitted along with the application for license (FCC Form 347). Program test authority will not be granted without this showing. Operation will not begin until the Commission specifically grants the program test authority. Further, the Commission reserves the right to require television translator and low power television stations to go off the air until interference problems are resolved. See subsections 74.703 (e) and (f) of the Commission's Rules.
