However, before commencing STV operation, you are directed to notify the Commission of the type of encoding/decoding system to be used (manufacturer and model) and the manner in which decoders will be made available to the public. Pursuant to Sections 74.731 and 73.644 of the Commission's Rules, the technical system to be used must have been approved in advance by the Commission. The Commission periodically publishes lists of approved STV systems.
