Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules.

Commission rules which became effective on February 16, 1999, have a bearing on this construction permit. - 1 This authorization is subject to the condition that low power television is a secondary service, and that low power television and television translator stations must not cause interference to the reception of existing or future full service television stations on either allotted NTSC or DTV channels, and must accept interference from such stations.
- 2 This authorization is entitled to displacement relief only in order to eliminate or avoid interference conflicts. Priority over pending Class A TV, LPTV, or TV Translator applications will not be afforded to the displacement application solely by virtue of operating in the 700 MHz Band.
- 3 This authorization is subject to the condition that any future modification will not result in a relocation within 121 km of the top 125 markets as described in Public Notice of Auction 81.
