This authorization re-issued to reflect special condition in regard to WMBC-TV.

Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules.

Commission rules which became effective on February 16, 1999, have a bearing on this construction permit. See Report & Order, Streamlining of Mass Media Applications, MM Docket No. 98-43, 13 FCC RCD 23056, Para. 77-90 (November 25, 1998); 63 Fed. Reg. 70039 (December 18, 1998). Pursuant to these rules, this construction permit will be subject to automatic forfeiture unless construction is complete and an application for license to cover is filed prior to expiration. See Section 73.3598.

1 The digital conversion work must be completed within 90 days.

The filtering system to reduce emissions the digital transmitter not to exceed -123 dBm in the channel 16 (482-488 MHz) Spectrum must be installed. The additional filtering provided must increase attenuation levels beyound the "Full Service Digital Mask" as indicated in your Consultants report dated February 19, 2009.

Upon completion of the new digital transmitter and filter installation a test will be required coordinated with representatives of the City of New York and the permittee's engineering staff present to validate that all interference to the Ch 16 fixed receivers has been eliminated.

Granting of this request does not waive the City of New York's right to petition the FCC under Rule and Order 04-80 if the interference continues to exist. Specifically that section 47 C.F.R. 74.703(e) is still in force and that WEBR-CD as a Class A Low Power TV station is authorized on a secondary basis to existing Public Safety Land Mobile uses and must correct whatever interference they cause to land mobile stations or cease operations.

Special operating conditions or restrictions:

- This authorization is also subject to the following condition: The licensee agrees to accept any interference resulting from  $\ensuremath{\mathtt{WMBC-TV's}}$ operations on channel 18 including:
  - a. WMBC-TV's currently authorized facilities.(BLCDT-20060830AMO) b. The WMBC-TV facilities authorized by BPCDT-20090414ABW

  - c. Any future applications for DTS facilities for WMBC-TV that fully comply with Commission's rules.
