Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules.

Commission rules which became effective on February 16, 1999, have a bearing on this construction permit. See Report & Order, Streamlining of Mass Media Applications, MM Docket No. 98-43, 13 FCC RCD 23056, Para. 77-90 (November 25, 1998); 63 Fed. Reg. 70039 (December 18, 1998). Pursuant to these rules, this construction permit will be subject to automatic forfeiture unless construction is complete and an application for license to cover is filed prior to expiration. See Section 73.3598.

Equipment and program tests shall be conducted only pursuant to Sections 73.1610 and 73.1620 of the Commission's Rules.

Special operating conditions or restrictions:

- This authorization is subject to the condition that low power television is a secondary service, and that low power television and television translator stations must not cause interference to the reception of existing or future full service television stations on either allotted NTSC or DTV channels, and must accept interference from such stations.
- During equipment tests, the permittee shall take adequate measures to identify and eliminate objectionable interference that may be caused to existing land mobile radio facilities in the 460-470 MHz band (or 806-816 MHz band) authorized prior to the date this construction permit is issued. Documentation that objectionable interference will not be caused to existing land mobile radio facilities shall be submitted along with the application for license (FCC Form 347). Program test authority will not be granted without this showing. Operation will not begin until the Commission specifically grants the program test authority. Further, the Commission reserves the right to require television translator and low power television stations to go off the air until interference problems are resolved. See subsections 74.703 (e) and (f) of the Commission's Rules.
