- 2 Subject to the condition that before program tests are authorized the transmitter employed must be type accepted or meet Commission type acceptance requirements at an actual power output as shown below. In the event the transmitter has not been type accepted at this power, the permittee shall, in the license application, provide full engineering data demonstrating compliance with Section 74.750 of the Commission's Rules. 130 WATTS
- 3 The authorization of a license to operate this station is conditioned upon the use of a transmitter that has been type accepted or meets Commission type acceptance requirements at a visual carrier frequency tolerance of plus/minus 1 kHz. In the event the transmitter has not been type accepted at this tolerance, the permittee shall, in the license application, provide full engineering data that demonstrates compliance with Section 74.750 (c) (3) (iii) of the Commission's Rules.
- 4 Your construction permit application did not identify the name, address and telephone number of a person who may be contacted in an emergency to suspend operation of this station, should such action be deemed necessary by the Commission.
