Special operating conditions or restrictions:

The relative field strength of neither the measured horizontally nor vertically polarized radiation component shall exceed at any azimuth the value indicated on the composite radiation pattern authorized by construction permit BNPED-20071018AFY.

A relative field strength of 1.0 on the composite radiation pattern herein authorized corresponds to the following effective radiated power:

0.250 kilowatt.

Principal minima and their associated field strength limits:

185 degrees True: 0.0110 kilowatt

- The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.
- Pursuant to 47 CFR Sections 73.7002(c) and 73.7005(b) the permittee/licensee is required to construct and operate for a period of four years of on-air operations technical facilities substantially as proposed and shall not downgrade service to the area on which the preference was based.
