- 3 Grant of this license application is conditioned on the continuous operation of the licensed facility for the twelve-month period following grant. The failure of the facility to so operate will result in the rescission of this grant, dismissal of the license application and the forfeiture of the associated construction permit pursuant to 47 C.F.R. § 73.3598(c) unless the licensee rebuts the presumption that the authorized facilities were temporarily constructed.
- 4 Real Presence Radio requests waiver of 47 C.F.R. Section 73.1125 to operate the proposed facility as "satellite" of co-owned noncommercial educational AM station KWTL (AM), Grand Forks, North Dakota, (Facility ID No.: 69201). Based upon the specific representations contained therein, the waiver request IS GRANTED. Applicant shall abide by each representation proffered in the waiver request.
- 5 Real Presence Radio requests waiver of 47 C.F.R. § 73.509 to allow Station KQFR, as authorized herein, to receive contour overlap from the 100 dBu contour of second adjacent channel Station KBHE-FM, Facility ID No. 58327, Rapid City, SD, BLED-19840416CB. We have afforded this request the "hard look" called for under WAIT Radio v. FCC, 418 F.2d 1153 (D.C. Cir. 1969), and find that the facts and circumstances presented in the applicant's justification are sufficient to establish that grant of the requested waiver is in the public interest. Accordingly, waiver of 47 C.F.R. § 73.509 IS HEREBY GRANTED. Furthermore, further modifications of Station KBHE-FM will not be construed as a "per se" modification of KQFR's facility. We have afforded this request the "hard look" called for under WAIT Radio v. FCC, 418 F.2d 1153 (D.C. Cir. 1969), and find that the facts and circumstances presented in the applicant's justification are sufficient to establish that grant of the requested waiver is in the public interest. Accordingly, waiver of 47 C.F.R. § 73.509 IS HEREBY GRANTED. Furthermore, further modifications of Station KASD(FM) will not be construed as a "per se" modification of KQFR's facility.
