Special operating conditions or restrictions:

- 2 Hawaii Public Radio, Inc. was granted a waiver of 47 C.F.R. § 73.1125 to allow the operation of this station as a "satellite" of co-owned noncommercial educational FM Station KIPO(FM), Honolulu, Hawaii (Facility ID No.: 26440). See Construction Permit BMPED-20130910ADK, granted September 27, 2013. Grant of this waiver is continued. Hawaii Public Radio, Inc. must abide by each representation proffered in the waiver request.
- 3 The permittee/licensee, in coordination with other users of the site, must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of the FCC guidelines.
- 4 The licensee has demonstrated compliance with the FCC radiofrequency electromagnetic field exposure guidelines based on the use of the antenna specified herein. If the licensee makes any changes in the facilities via a modification of license application in accordance with 47 C.F.R. Section 73.1690(c), the subsequent FCC Form 302-FM, application for license, must include a revised RF field showing to demonstrate continued compliance with the FCC guidelines.
