Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules.

Commission rules which became effective on February 16, 1999, have a bearing on this construction permit. See Report & Order, Streamlining of Mass Media Applications, MM Docket No. 98-43, 13 FCC RCD 23056, Para. 77-90 (November 25, 1998); 63 Fed. Reg. 70039 (December 18, 1998). Pursuant to these rules, this construction permit will be subject to automatic forfeiture unless construction is complete and an application for license to cover is filed prior to expiration. - 1 The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.

- 3 This application is being granted prior to the completion of the International Telecommunications Union (ITU) registration process. Therefore, any construction of and operation with the facilities specified herein is at applicant's own risk and subject to modification, suspension or termination without right to hearing, if found by the Commission to be necessary in order to conform to the provisions of the registration process of the ITU, and to bilateral and other multilateral agreements between the United States and other countries.

## Special operating conditions or restrictions:

- 4 1) The authority granted herein is subject to the condition that the field strength of the fundamental signal produced by the permitted/licensed facility shall not exceed 27 mV/m as measured at the Federal Communications Commission's Santa Isabel, Puerto Rico monitoring station.
- 2) In the event that the 27 mV/m limitation is exceeded, or if interference occurs to the monitoring, direction finding, or related operations of the Federal Communications Commission's Santa Isabel, Puerto Rico monitoring station due to intermodulation, spurious emissions, or any other reason related to the operation of the this transmitter, the permittee/licensee shall take such immediate corrective action as is necessary to eliminate the interference. This shall include responsibility for furnishing, installing and adjusting transmitter filter circuits, shielding, or other corrective devices. If these measures fail to eliminate interference to FCC operations caused by the presence of the permittee/licensee's signal, or if the field intensity exceeds 27 mV/m, the permittee/licensee shall immediately reduce power to the extent necessary to eliminate the interference and /or comply with field strength limit. After determining this lower power level, the permittee/licensee shall immediately apply for a Special Temporary Authority (STA) and shall file an application to the Commission for the altered parameters.
- 3) The applicant shall advise the Enforcement Bureau's Spectrum Enforcement Division, and the Media Bureau's Audio Division, of the exact date when it intends to commence normal operations, and another notification when normal operations actually commences.
