Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules.

Commission rules which became effective on February 16, 1999, have a bearing on this construction permit. See Report & Order, Streamlining of Mass Media Applications, MM Docket No. 98-43, 13 FCC RCD 23056, Para. 77-90 (November 25, 1998); 63 Fed. Reg. 70039 (December 18, 1998). Pursuant to these rules, this construction permit will be subject to automatic forfeiture unless construction is complete and an application for license to cover is filed prior to expiration. See Section 73.3598.

- 2 This authorization includes a waiver of Section 74.705(b)(5) of the Commission's Rules to permit station construction within 32 kilometers of the full-service television station specified below. This waiver will convey for minor changes to the facility, except for those related to channel displacement, and for assignment or transfer of the authorization. The permittee or licensee is responsible to eliminate any objectionable interference to the off-air reception of full-service television stations resulting from the operation of this station.
