In the event the transmitter has not been type accepted at this tolerance, the permittee shall, in the license application, provide full engineering data that demonstrates compliance with Section 74.750 (c) (3) (iii) of the Commission's Rules.
- This authorization is subject to the condition that low power television is a secondary service, and that low power television and television translator stations must not cause interference to the reception of existing or future full service television stations on either allotted NTSC or DTV channels, and must accept interference from such stations.
- Subject to the condition that before program tests are authorized the transmitter employed must be type accepted or meet Commission type acceptance requirements at an actual power output as shown below. In the event the transmitter has not been type accepted at this power, the permittee shall, in the license application, provide full engineering data demonstrating compliance with Section 74.750 of the Commission's Rules.
