This authorization is re-issued October 30, 2008, to reflect the grant of a Main Studio Satellite Waiver see (Special Operating Condition # 3)

Subject to the provisions of the Communications Act of 1934, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this license, the licensee is hereby authorized to use and operate the radio transmitting apparatus herein described.
