In the event the transmitter has not been type accepted at this tolerance, the permittee shall, in the license application, provide full engineering data that demonstrates compliance with Section 74.750 (c)(3)(iii) of the Commission's Rules.
- This authorization is subject to the condition that low power television is a secondary service, and that low power television and television translator stations must not cause interference to the reception of existing or future full service television stations on either allotted NTSC or DTV channels, and must accept interference from such stations.
- This authorization is entitled to displacement relief only in order to eliminate or avoid interference conflicts. Priority over pending Class A TV, LPTV, or TV Translator applications will not be afforded to the displacement application solely by virtue of operating in the 700 MHz Band.
