On Saturday, March 7th, WAKA CBS 8 made plans to preempt all three hours of E/I programming due to a Presidential visit and subsequent news coverage related to the 50th Anniversary of the Selma march. This visit was delayed by the White House, so normal E/I programming aired. As a result of the preemption planning, second home broadcasts were also advertised and executed on the same weekend. In other words, each core program aired in its regularly scheduled time Saturday and also in its second home that weekend. For 398 reporting purposes, we are counting the regularly scheduled E/I programming, not the rescheduled programming, which also aired as advertised.
