This program stream had carried 3 hours per week of Children's Educational and Informational programming as listed in this report. Question #8a and 8b were answered 336 and 6 as if WFGX 35.3 had aired for the entire quarter. Some of the non-"core" educational/informational material aired by WFGX-TV is in the form of Public Service Announcements targeted to children.
