As a result, the studio equipment was stolen and the licensee was unable to provide children's programming. In addition, the studio was vandalized and files and records were taken and/or destroyed. A report was taken by the Gwinett County Police Department and a claim was filed with the licensee's insurance carrier. (Copies of these reports can be provided to the Commission upon request as FCC Form 398 does not allow attachments.) Licensee is in the process of replacing the equipment so that it can resume providing children's programming. Its inability to provide children's programming was due to circumstances beyond its control.
